

EXIM Thailand, BOI and DEP to Organize Subregional Export and Overseas Investment Forum

EXIM Thailand, in cooperation with the BOI and DEP, will host the first Export and Overseas Investment Forum joined by heads of Thai, Cambodian, Vietnamese and Laotian state agencies as well as business leaders. Apart from an entire-day seminar, the event will feature booth displays which provide integrated financial and information services to sharpen the competitive edge of Thai enterprises. This special event will take place in late May 2007 at Sofitel Central Plaza Bangkok.

Dr. Apichai Boontherawara, President of Export-Import Bank of Thailand (EXIM Thailand), said EXIM Thailand, the Board of Investment of Thailand (BOI) and Department of Export Promotion (DEP), would jointly organize the "Export and Overseas Investment Forum" on Monday, May 28, 2007 from 8.00 to 16.00 hrs. at Vibhavadee Ballroom A-C, Sofitel Central Plaza Bangkok. The event includes panel discussions titled "Public Policies on Export and Overseas Investment Promotion" and "Overseas Investment Opportunities and Possibilities" with guest speakers from public and private agencies in Thailand, Cambodia, Vietnam and Lao PDR. According to EXIM Thailand President, this is the first collaboration of its kind between public and private sectors at an international level. The aim is to enhance the preparedness and competitiveness of Thai entrepreneurs wishing to expand their businesses in the neighboring countries where there exist plenty of demands for Thai goods and services for their national infrastructural and industrial development.
