

EXIM Thailand Appoints New Executive Vice Presidents and Department Heads

EXIM Thailand appointed Mrs. Chomsuda Tuntariyanond as Executive Vice President for Treasury; Mrs. Kasina Srisaan as Executive Vice President for Banking Operations and Business Research; Mr. Soravoot Sukhakit as First Vice President, Head of Debt Administration and Credit Procedure Department and Mr. Phairoj Pongsuvann as First Vice President, Head of Human Resources Department, effective on June 1, 2012.

Export-Import Bank of Thailand (EXIM Thailand) appointed two new Executive Vice Presidents, namely, **Mrs. Chomsuda Tuntariyanond** and **Mrs. Kasina Srisaan**. EXIM Thailand also appointed **Mr. Soravoot Sukhakit** as First Vice President in charge of Debt Administration and Credit Procedure Department overseeing credit approval, debt collection and restructuring, collateral operations, contract preparation and other legal documents and issues. **Mr. Phairoj Pongsuvann** was appointed as First Vice President overseeing Human Resources Department which engages in human resources management and development.
